The purpose of the following RULES is to allow for and create a safe place where everyone can participate. The rules are about respect, for oneself, others, RSA, and the Church, which has graciously opened its doors to each of us. Parents/Guardians are expected to discuss these RULES and these expectations with their YOUTH. Please read the RULES and WAIVER and then sign below in acknowledgment and acceptance of them.

RULES

- **NO VIOLENCE** (or weapons), **NO ALCOHOL, NO TOBACCO, NO DRUGS** of any sort, and **NO SEXUAL ACTIVITY** or inappropriate behavior will be tolerated by YOUTH.
- **STAY INSIDE CHURCH:** YOUTH will stay inside the church building during the dance. Youth will not leave or enter the building without permission from an RSA chaperone (appointed RSA adult volunteer).
- **RESPECT PEOPLE AND PROPERTY:** YOUTH will respect other youths, parents, and volunteers. In addition youth will respect the property of the following: the Church, other youths, RSA, and the RSA Dance Committee, including, but not limited to, the building, furniture, dance props and decorations.

If YOUTH does not abide by the above RULES, YOUTH will be removed from the Dance by a chaperone and YOUTH'S parent/guardian will be contacted immediately to remove YOUTH from the premises.

WAIVER

I agree, and do hereby release and hold harmless, RSA and its volunteers, chaperones, administration, Board members, Dance Committee, HSOBX, other co-ops and the Church, and its employees and representatives, from any and all liability which may arise to either person(s) or property, which myself or my child(ren) may sustain while engaged in the activity conducted, including, but not limited to, any damages, loss or injuries.
